Cookie policy on <u>www.tapaya.com</u>

(hereinafter referred to as the "Policy")

1. INTRODUCTORY PROVISIONS

- 1.1. Tapaya s.r.o., ID No.: 234 76 541, with its registered office at Uralská 689/7, Bubeneč, 160 00 Prague 6, registered in the Commercial Register maintained by the Municipal Court in Prague, file no. C 427691 (hereinafter referred to as the "**Company**") is the operator of the web interface www.tapaya.com.
- 1.2. This Policy applies to users natural persons who browse, read, or enter their data on the website <u>www.tapaya.com</u> (hereinafter referred to as the "**Website**") or provide their data to the Company through third-party websites. Among other things, this Policy is intended to properly inform Website users about the use of cookies and the possibility of disabling cookies.
- 1.3. This Policy describes how data from users of the Company's websites is collected, stored, processed, and used, and how the Company uses cookies to obtain and process information about users of its Websites.
- 1.4. For the purposes of this Policy, the term "cookies" refers to cookies and other similar technologies (such as pixel tags, web beacons, or device identifiers) that may automatically collect data when you visit the Website. The information collected in this way may include your IP address, browser type, operating system, referring URL, information about your activities on the Website, and the dates and times of your visits to the Website.

2. WHAT ARE COOKIES

2.1. Cookies are small text files containing brief pieces of information that may be stored on a user's device when visiting any website.

2.2. Cookies in particular:

- a) used for effective navigation on the Website, personalization, saving preferences, and generally improving the user experience on the Website;
- b) enable us to distinguish whether a particular user has visited the Website in the past or is a new visitor, and assist in recording statistics about visitors to the Website; and/or
- c) help display advertisements tailored to the interests of specific users on the Website.
- 2.3. Cookies can be divided according to who places them on your Website, i.e. into:
 - a) First-party cookies their validity is limited to the domain of the website you are viewing. These cookies are considered safer; and
 - b) Third-party cookies these are placed using a script from another domain. This allows users to be tracked across domains. They are often used to evaluate the effectiveness of advertising campaigns.



3. PURPOSE OF USING COOKIES

- 3.1. The Company uses cookies on its website for the following purposes:
 - a) essential enable basic website functions (e.g., logging in) or pages (e.g., playing videos, sharing content, etc.); user consent is not required to use these strictly necessary cookies;
 - b) functional they facilitate control and improve the functionality of websites, serve to remember user preferences and increase security;
 - c) analytical used to collect non-anonymous data about user behavior. Based on this data, the Company may modify the Website to improve the user experience; and
 - d) marketing the Company does not use these cookies.

4. COOKIES USED ON THE WEBSITE

4.1. **ESSENTIAL COOKIES:** When visiting and using the Website for informational purposes only, i.e. if the user does not register or give us consent, we only collect personal data that the browser transmits to our server, which is necessary for us to display the Website and ensure the stability and security of its use.

4.2. **FUNCTIONAL COOKIES:** Facilitate control and improve the functionality of the Websites. We use them to activate specific Website features and configure them according to user preferences (e.g., language). Functional cookies also serve to remember user preferences for future visits to the Website and to increase its security. They do not collect information that could uniquely identify users.

4.3. **ANALYTICAL COOKIES:** These cookies are used to improve the functioning of the Website. They enable us to recognize and determine the number of visitors and track how visitors use the Website. They help us improve the way the Website works, for example by enabling users to easily find what they are looking for. We also use these tools to analyze and regularly improve the functionality of our Website. We may use the statistics obtained to improve user comfort. These cookies do not usually collect information that could uniquely identify a user.

8. SHARING INFORMATION

8.1. The Company may share information obtained through your activity on the Website with third parties for the purpose of administering the Website or conducting marketing activities on behalf of the Company.

9. FINAL PROVISIONS

- 9.1. The Company is entitled to unilaterally amend or supplement this Policy at any time. In the event of any amendment to this Policy, the Company shall notify users of such amendments in advance and in an appropriate manner so that users have an objective opportunity to familiarize themselves with them.
